Important:

The basic reason for introducing NEMT is to provide superior support to the senior persons and for physically challenged peoples. Under ADA (American with Disability Act), it is important to arrange special transportation services for providing good health support to the citizens

Non emergency medical transportation defined
Under federal law, which recognized
State Medicaid agencies must

- O Use appropriate form of transportation
- O Ensure necessary transportation to and from providers
- O Include coverage for transportation and related travel expenses necessary to secure medical examinations and treatment



- O Medical needs are immediate
- O Symptoms are severe
- O Symptoms may be life threatening such as heart attack
- O Symptoms may be due to a serious event such as accident

NEMT Ethics

Most transportation providers want to do right things. Those provides:

- O Claims bills properly
- O Follow Medicaid rules
- **O** Understand fraud schemes
- O Take time to learn preventive strategies

Fraud Schemes

- **O** Unnecessary services
- Vehicles were not modified according to Medicaid rules
- Billed for undelivered services
- **O** Charges exceeded actual services
- **O** Lifetime exclusion
- O Any other fraud or abuse

It is important to understand the rules for **Fraud** reducing such types of frauds. Thus prevention **Medicaid** defines these tips tips

- O Beneficiary's name
- **O** Medicaid identifier
- O Location of pick up and drop-off
- O Date and time of pickup and drop-off
- O Loaded mileage

Important:

Medicaid collects such information from the transportation broker after the completion of journey to reduce the fraudulent service actions. These form must be signed by the beneficiary.
